Contract Agreement

This Agreement made on the 11th Day of December, 2017 between the Director Bangladesh Film Archive, F-5, Agargaon Administrative Area, Sher-e-Bangla Nagar Dhaka-1207, Bangladesh (hereinafter called "The Procuring Entity") of the one part and M/S. Navana Ltd. 205-207 Tejgaon I/A, Dhaka-1208. (hereinafter called "The Contractor") of the other part.

WHEREAS, the Procuring Entity invited Tenders for certain Works, Viz, 01 (one) Unit Brand new Toyota Hiace 12 seated Microbus, Country of Origin and assembled: Japan Toyota Motor Corporation, Model:TRH203R-REMDK, Brand New, Latest Model 2017, Petrol Engine, 2694 c.c., 04 (four) doors (including rear) with Govt. BRTA Registration, 90 Liter CNG Cylinder and standard tools set and other accessories mentioned in the offer has accepted a Tender by the Supplier for the supply of those goods and related services in the sum of **Taka 39,99,500/- (Taka Thirty Nine Lac Ninety Nine Thousand Five Hundred)** only including all Govt. VAT & Tax hereinafter called "The Contract Price".
